Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.06mm width (at base) x 1.24mm depth, with a hollow top and shoulders, and open back settings.

Feature 'cross over' style ring. Two rows with a total of twenty-one round brilliant cut diamonds, cross over in the centre of band. The diamonds graduate in size, largest to the centre, and channel set. The settings are secured between tapering shoulders, of the plain and polished band. Rhodium plating to the setting areas.

Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Ring size: P.

The ring contains:

Twenty One channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).
Dimensions = 1.52mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.77mm(Dia) x 1.08mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.47 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 4.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
