Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.85mm width (at base) x 1.21mm depth, with a hollow top and shoulders, and a cut out curved underrail.

Feature 'cross over' style ring. One central row of round brilliant cut diamonds, graduating in size, and channel set. There are also two outer rows of single cut diamonds, claw set. There is a total of nineteen round brilliant cut diamonds, and a total of eighty single cut diamonds. The settings are secured between the shoulders of the plain and polished band. Rhodium plating to the diamond setting areas.



Polished finish. Stamped '10K michael hill 1.00' - acid tested as 9 carat gold. Ring size: O 1/2.

The ring contains:

Nineteen channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to light tinted brown".

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.52mm(Dia) x 1.54mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.68ct (estimated - see NOTE below)

Eighty claw set single cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "H to light tinted brown".

Dimensions (average) = 0.95mm (diameter)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 5.59 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
