Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 18ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature central six claw setting, housing one round synthetic moissanite, claw set. Around the base of the setting, is one row of eight round synthetic moissanites, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 5.23mm (ave. length) x 5.23mm (ave. width) x 5.58mm (ave. depth).

Polished finish.

Stamped '750(butterflies)' - acid tested as 18 carat gold.

The earrings contain:

Two claw set round synthetic moissanites, colour is "colourless".

Dimensions (average) = 5.05mm(Dia) x 3.08mm(D-estimated)

Total Weight = 0.82ct (estimated - see NOTE below)

Sixteen claw set round synthetic moissanites, colour is "colourless".

Dimensions (average) = 0.82mm(Dia) x 0.50mm(D-estimated)

Total Weight = 0.05ct (estimated - see NOTE below)



Total Item Weight = 1.22 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 1.05 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
