## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.03mm width (at base) x 1.27mm depth, with open back settings, and a curved underail.

Feature pear shaped top plate, housing seven baguette cut diamonds, to the centre, and seven round brilliant cut diamonds, all varying in size, and claw set. Surrounding is one row of thirty round brilliant cut diamonds, claw set. The top plate is supported with a decorative pierced gallery, and in between the 'split' style shoulders, of the plain and polished band. Rhodium plating to the top plate.



Polished finish.

Stamped '9K 0.50CT' - acid tested as 9 carat gold.

Ring size: N.

The ring contains:

Seven claw set baguette cut diamonds, clarity is "Si & P1" (mixed), colour is "G".

Dimensions = 2.69mm(L) x 1.14mm(W) x 0.83mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.07mm(L) x 1.78mm(W) x 1.30mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.19mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.74mm(Dia) x 1.06mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.76 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.66 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
