One pair of, 10ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature cushion shaped top plate, housing nine round brilliant cut diamonds, to the centre, claw set. Surrounding is one row of twenty round brilliant cut diamonds, claw set. The earrings are finished with post and butterfly attachments.
