Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.89mm width (at base) x 0.85mm depth, with open back settings, and a 'cross over' style underrail.

Feature central semi-bezel setting, housing one round brilliant cut diamond, end set. The setting is created using the 'cross over' style underrail, lengthening out from the extended and square shoulders, of the plain and polished band. Each of the shoulders houses five round brilliant cut diamonds, graduating in size, and channel set. The gallery is embellished with two bezel settings, each housing one round brilliant cut diamond, bezel set.

Polished finish.

Stamped '750 AC16' - acid tested as 18 carat gold.

Ring size: S 1/2.

The ring contains:

One end set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 5.40mm(L) x 5.40mm(W) x 3.83mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to light tinted brown".

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.23mm(Dia) x 1.36mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 5.36 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
