Valuation for Traditional Retail Insurance Replacement

One, 18ct yellow gold, gemset, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.13mm width (at base) x 0.70mm depth, with open back settings.

Feature 'over lap' style ring, with one of the rounded terminations overlapping the other. This termination houses one row of four round brilliant cut diamonds, channel set. The terminations extend out from the plain and polished band.



Polished finish.

Stamped '750 DL' - acid tested as 18 carat gold.

Ring size: Z+1.

The ring contains:

Four channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G".

Dimensions = 3.10mm(Dia) x 1.89mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.24mm(Dia) x 1.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 5.35 grams Total Gemstone Weight = 0.50ct

Total Metal Weight = 5.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
