Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, wide, 'triple wire' style band of 5.22mm width (at base0 x 1.25mm depth, with a hollow top and shoulders, and open back settings.

Feature two rows of nine Princess cut diamonds, spanning across the top of the band. The diamonds slightly graduate in size, largest to the centre, and invisibly set. The settings are secured between the tapering shoulders of the plain and polished band.



Polished finish.

Stamped 'FCJ 750' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

Eighteen invisibly set Princess cut diamonds, clarity is "Vs", colour is "G".

Dimensions = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(L) x 2.15mm(W) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 9.59 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 9.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
