Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow and white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.99mm width (at base) x 1.11mm (depth), with curved underrail, open back settings, underneath.

Feature, "oval-shaped" cluster design, & shoulder stones. Comprising, a raised, double row cluster to top, houses twenty eight, illusion & claw set. The extended shoulders, of the band tapers up, splits one cross over to each centre & single row across the band each side, Containing a total of fortytwo round brilliant cut diamonds, claw set.

Polished finish, stamped "9K, 1.00ct" - acid tested as 9 carat gold. Finger size = N1/2.

The ring contains;

Eighteen illusion claw set round brilliant cut diamonds, clarity is "P3", colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.84mm (average diameter) x 1.12mm (D-estimated)
Total Weight = 0.40ct (estimated - see NOTE below).

Fifty Two claw set round brilliant cut diamonds, clarity is "P3", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.31mm (average diameter) x 0.80mm (D-estimated) (smallest)
Dimensions = 1.47mm (average diameter) x 0.90mm (D-estimated) (largest)
Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 4.55 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 4.35 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
