## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.07mm width (at base) x 1.03mm depth, with a hollow top and shoulders, and open back settings.

Feature round white gold top plate, housing thirty-seven round brilliant cut diamonds, varying slightly in size, and pave set. The top plate is supported with an open wire base, and is secured to the top of the plain and polished yellow gold band.

Polished finish.

Stamped '750 15A&C' - acid tested as 18 carat gold.

Ring size: S.

The ring contains:

Thirty Seven pave set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to J" (mixed).  
Dimensions (average) = 1.92mm(Dia) x 1.17mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 6.38 grams  
Total Gemstone Weight = 1.00ct  
Total Metal Weight = 6.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
