## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-finished construction.

Plain, narrow, low half round, tapered band of 3.94mm width (at base) x 0.89mm depth.

Feature three diagonal rows of three round brilliant cut diamonds, across the top of the raised and rounded band, channel set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: Z+1.

The ring contains:

Nine channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G".  
Dimensions = 2.75mm(Dia) x 1.68mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 2.86mm(Dia) x 1.74mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.72ct (estimated - see NOTE below)

Total Item Weight = 10.40 grams

Total Gemstone Weight = 0.72ct

Total Metal Weight = 10.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
