Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.57mm width (at base) x 1.35mm depth, with a curved underrail.

Feature white gold six claw setting, housing one early round brilliant cut diamond, claw set. The settings is secured between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18CT PLAT' - acid tested as 18 carat gold and platinum.

Ring size: M 1/2.

The ring contains:

One claw set early brilliant cut diamond, clarity is "P1", colour is "G".
Dimensions = 4.33mm(L) x 4.27mm(W) x 2.35mm(D-estimated)
Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 2.23 grams

Total Gemstone Weight = 0.26ct

Total Metal Weight = 2.18 grams (estimated)

NOTE: The diamond has a large fracture to the crown. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
