Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, flexible link bracelet, of hand-assembled construction.

Feature rectangle curved top plate, housing on central row of nine round brilliant cut diamonds, channel set. Either side of the central setting, is embellished two 'chevron' shaped rows of five round brilliant cut diamonds, channel set. The plate is secured in between a 'panther' link style chain, and is finished with a box clasp, and two figure 8 safety catches.

Bracelet dimensions = 18.50cm (ave. length) x 10.03mm (ave. width) x 1.41mm (ave. depth).

Top plate dimensions = 11.69mm (ave. length) x 2.60mm (ave. depth).

Polished finish.

Unstamped - acid tested as 18 carat gold.

The bracelet contains:

Nine channel set round brilliant cut diamonds, clarity is "Vs", colour is "G to I" (mixed).

Dimensions (average) = 3.35mm(Dia) x 2.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.31ct (estimated - see NOTE below)

Twenty channel set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.23mm(Dia) x 1.36mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.96ct (estimated - see NOTE below)

Total Item Weight = 43.03 grams Total Gemstone Weight = 2.27ct Total Metal Weight = 42.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
