Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, 'two stone' style ring, of handmade construction.

Plain, narrow, low half round, tapered band of 1.35mm width (at base) x 1.11mm depth, with open back settings, and a curved underrail.

Feature 'vintage' 'two stone' style ring, with two six claw settings, each housing one early brilliant cut diamond, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. The shoulders are embellished with 'strap' detail.

Polished finish.

Stamped 'P 18K' - acid tested as 18 carat gold.

Ring size: S.

The ring contains:

One claw set early brilliant cut diamond, clarity is "P2", colour is "G".
Dimensions = 4.03mm(L) x 3.95mm(W) x 2.13mm(D-estimated)
Total Weight = 0.21ct (estimated - see NOTE below)

One claw set early brilliant cut diamond, clarity is "P1", colour is "H".
Dimensions = 4.13mm(L) x 3.99mm(W) x 2.51mm(D-estimated)
Total Weight = 0.25ct (estimated - see NOTE below)



Total Item Weight = 2.01 grams Total Gemstone Weight = 0.46ct Total Metal Weight = 1.92 grams (estimated)

NOTE: Both of the diamonds have significant chips to the girdle. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
