Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 14ct yellow & white gold, multistone ring, of cast construction.

Plain, narrow, half round, tapered band, measures 2.15mm width (at base) x 1.30mm depth, with open back, settings underneath.

Feature, "trilogy cluster style" design. Comprising, three raised cluster claw setting to top, rhodium polished to highlight, contains a total of twenty one round brilliant cut diamonds, various sizes, all claw set. The extended shoulders, of the yellow gold band tapers up to the trilogy setting, from both sides.

Polished finish, stamped "14K" - acid tested as 14 carat gold. Finger size = R1/2.

Nine illusion claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.65mm (average diameter) x 1.62mm (D-estimated) (smallest)
Dimensions = 3.25mm (average diameter) x 1.98mm (D-estimated) (largest)
Total Weight = 0.90ct (estimated - see NOTE below).

Twelve claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated)
Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 5.67 grams, Total Gemstone Weight = 1.30ct, Total Metal Weight = 5.41 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
