Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow and white gold & diamond set, flexible link bracelet.

Feature, "cluster style line bracelet", Comprising, twenty four white gold, square-shaped cluster settings, alternate with yellow gold, s-shaped links. The bracelet contains three hundred & sixty single cut diamonds, claw set. The bracelet comes with box clasp closure & is fitted with a figure 8 safety catch, to one side.

Polished finish, stamped "9K KK" - acid tested as 9 carat gold.

Bracelet dimensions = 18.50cm (total length) x 9.90mm (width) x 3.82mm (depth).

The bracelet, contains:

- Three Hundred And Sixty claw set single cut diamonds, clarity is "P2 & P3"(mixed), colour is "K to L"(mixed), medium cut quality.
- Dimensions = 1.32mm (average diameter) (smallest)
- Dimensions = 1.46mm (average diameter) (largest)
- Total Weight = 4.30ct (estimated - see NOTE below).

Total Item Weight = 17.97 grams, Total Gemstone Weight = 4.30ct, Total Metal Weight = 17.11 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar bracelet, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
