### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 10ct yellow gold & diamond set, flexible link necklace. Feature, "curved bar to front" with flexible links at ends, Housing a total of sixty six round brilliant cut diamonds various sizes, claw set. The other links moving to the back are bead set, rhodium plated to highlight. The necklace is open to back, with a box clasp closure fitted, with a figure eight clip, to side.

Polished finish, stamped "DTC, 10K" - acid tested approximately 10 carat gold.

Necklace dimensions = 46.00cm (total length) x 5.13mm - 9.19mm (width) x 3.11mm - 4.40mm (depth).

The necklace contains:

Six claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 2.22mm (average diameter) x 1.35mm (D-estimated) (smallest)  
Dimensions = 2.32mm (average diameter) x 1.42mm (D-estimated) (largest)  
Total Weight = 0.26ct (estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.36mm (average diameter) x 0.83mm (D-estimated) (smallest)  
Dimensions = 1.67mm (average diameter) x 1.02mm (D-estimated) (largest)  
Total Weight = 0.24ct (estimated - see NOTE below).

Forty Four claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.20mm (average diameter) x 0.73mm (D-estimated) (smallest)  
Dimensions = 1.28mm (average diameter) x 0.78mm (D-estimated) (largest)  
Total Weight = 0.25ct (estimated - see NOTE below).



Total Item Weight = 18.75 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 18.60 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar necklace employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
