## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.00mm width (at base) x 0.95mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central 'flower' style cluster, housing seven round brilliant cut diamonds, largest to the centre, and claw set. The setting is secured to the underrail, and in between the extended and square shoulders of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, claw set.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.32ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 1.41mm(Dia) x 0.86mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 3.50 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 3.41 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
