## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand assembled, raised 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.84mm width (at base) x 0.79mm depth, with cut-out underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised cluster setting to top, houses one round brilliant cut diamond, to centre, claw set. Surrounded by nine round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to pointed end terminations, both sides. Each shoulder contains, six round brilliant cut diamonds, tapering sizes, claw set.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold.

Finger size = T.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 3.79mm (average diameter) x 2.31mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Twenty One claw set round brilliant cut diamonds, clarity is "S & P1"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 2.48 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.40 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
