Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.22mm width (at base) x 0.59mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature three round brilliant cut diamonds, graduating in size, largest to the centre, spanning across the top of the band, claw set. The gallery and shoulders are embellished with a total of twenty-eight round brilliant cut diamonds, varying in size, and bead set. Rhodium plating to the diamond setting areas.

Polished finish. Stamped '14K RT' - acid tested as 14 carat gold. Ring size: N.

The ring contains:

Three claw set round brilliant cut diamonds, clarity is "P3", colour is "H to I" (mixed).

Dimensions = 4.00mm(Dia) x 2.44mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.59mm(Dia) x 2.80mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.85ct (estimated - see NOTE below)

Twenty Eight claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 3.76 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
