Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.53mm width (at base) x 1.15mm depth, with closed back settings.

Feature 'cross over' style ring, with four rows of single cut diamonds, graduating in size, crossing over in the centre of the band. There is a total of one hundred and fourteen single cut diamonds, channel and claw set. The settings are secured between the tapering shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped 'illegible stamp' - acid tested as 9 carat gold.

Ring size: N 1/2.

The ring contains:

One Hundred And Fourteen channel and claw set single cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "H to J" (mixed).

Dimensions = 0.80mm (diameter) (smallest)

Dimensions = 1.30mm (diameter) (largest)

Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 9.53 grams

Total Gemstone Weight = 0.70ct

Total Metal Weight = 9.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
