## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.54mm width (at base) x 1.10mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature one row of five round brilliant cut diamonds, graduating in size, largest to the centre. Alternating with four rows of two round brilliant cut diamonds, spanning across the top of the band, all claw set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '18K 750' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

Thirteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.50mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 2.78 grams

Total Gemstone Weight = 0.75ct

Total Metal Weight = 2.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
