Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's,hand finished raised, 18ct white gold & gemset, three stone ring. Plain, wide, flat, tapered band, measures 4.53mm width (at base) x 0.93mm depth, with curved underrail, open back settings, underneath.

Feature, "trilogy style" design. Comprising, a raised, railed four claw setting to top, houses one cushion shaped, synthetic sapphire, claw set. Drops to each side one end setting, housing one baguette cut diamond, end set. The extended shoulders, of the band, tapers up to the top, from both sides.



Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = M.

the ring contains;

One claw set cushion-shaped, faceted, synthetic sapphire, colour is "medium light blue".

Dimensions = 8.50mm (L) x 7.50mm (W) x 4.30mm (D-estimated)

Total Weight = 2.85ct (estimated - see NOTE below).

Two end set baguette diamonds, clarity is "Vs & Si"(mixed), colour is "H", medium cut quality.

Dimensions = 3.20mm (L) x 1.90mm (W) x 1.39mm (D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 5.97 grams, Total Gemstone Weight = 3.01ct, Total Metal Weight = 5.37 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
