One, 9ct yellow gold and 9ct white gold, flexible link bracelet, of hand-assembled construction.

Feature thirty white gold illusion settings, each housing one round brilliant cut diamond, illusion set. Each of the settings is separated with an articulated 's' shaped decorative yellow wire. The bracelet is finished with a box clasp and a hinged safety catch.

Bracelet dimensions = 19.00cm (ave. length) x 5.03mm (ave. width) x 2.47mm (ave.depth).

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

The item contains:

Thirty illusion set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "light tinted brown". Dimensions (average) = 2.07mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 10.83 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 10.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bangle employing similar materials and techniques being for a retail insurance purpose only.
