Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct yellow and white gold, diamond set, pendant.

Feature, "drop circular style" pendant. Comprising, a rub-over setting of white gold, contains one round brilliant cut diamond, rub-over set, open to back underneat. Suspended from a v-shaped yellow gold bail, attached to top.

Polished finish, unstamped - acid tested as 18 carat gold.

Pendant dimensions = 12.03mm (total length inclusive) x 6.13mm (width) x 4.29mm (depth).

The pendant contains:

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "I", medium cut quality.

Dimensions = 5.00mm (average diameter) x 3.32mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 1.13 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 1.03 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
