Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of hand-assembled raised, 18ct yellow gold & gemset, drop stud earrings.

Feature, each comprising, a curved single channel set row, contains six round brillaint cut diamonds taper sizes, channel set. Both with plain post & large buttefly fittings, attached.

Polished finish, stamped "18" - acid tested as 18 carat gold.

Earrings dimensions = 14.40mm (L) x 3.49mm (W) x 4.56mm (D).

The earring contains:

Twelve channel set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.50mm (average diameter) x 1.53mm (D-estimated) (smallest)

Dimensions = 2.60mm (average diameter) x 1.59mm (D-estimated) (largest)

Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 3.52 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 3.37 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
