Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct white gold & gemset, multistone ring.

Plain, narrow, low half round, tapered band, measures 2.19mm width (at base) x 1.30mm depth, with cut out, curved underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising a raised four claw setting to top, sapphire claw set. Drops to a scolloed surround with a millgrain edge, contains eight diamonds, bead set. The extended shoulders, of the plain band tapers up to pointed end terminations, to both sides.



Polished finish, stamped "18K 750 ANTON, 0.777ct" - acid tested as 18 carat gold. Finger size = L1/2.

The ring contains

One claw set round natural sapphire, colour is "medium dark blue". Dimensions = 4.99mm (average diameter) x 3.04mm (D-estimated) Total Weight = 0.55ct (estimated - see NOTE below).

Eight bead set round brilliant cut diamonds, clarity is "Si, P1 & P2" (mixed), colour is "H to I" (mixed), medium cut quality. Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 3.45 grams, Total Gemstone Weight = 0.80ct, Total Metal Weight = 3.29 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
