## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand finished, raised 10ct yellow gold & gemset, multistone ring.

Plain, wide, half round, tapered band, measures 2.17mm width (at base) x 1.29mm depth, tapers up to 19.15mm width (at top), with cut out & curved underrail, open back settings, underneath.

Feature, "cushion shaped cluster style ring design. Comprising, four tier drop, contains ninety six round brilliant cut diamonds, tapering sizes, claw set. The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "10K 2.00TDW, michael hill" - acid tested approximately 10 carat gold.

Finger size = S.

The ring contains;

Ninety Six claw set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to J"(mixed), medium cut quality.  
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)  
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)  
Total Weight = 2.00ct (estimated - see NOTE below).

Total Item Weight = 8.76 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 8.36 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
