Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.41mm width (at base) x 1.16mm depth, with open back settings.

Feature white gold top plate, housing one row of nine round brilliant cut diamonds, graduating in size, largest to the centre, and end set. The top plate is secured between the shoulders of the plain and polished yellow gold band.



Polished finish.

Stamped '750 unknown makers mark' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

Nine end set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions = 2.33mm(Dia) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.82mm(Dia) x 1.72mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.47 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.37 grams (estimated)
