Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.81mm width (at base) x 0.92mm depth, with open back settings, and a curved underrail.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished yellow gold band. Each of the shoulders houses one row of five round brilliant cut diamonds, graduating in size, largest to the centre, and channel set.

Polished finish.

Stamped '750 GM16' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "J".

Dimensions = 3.75mm(L) x 3.72mm(W) x 2.60mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "light tinted brown".

Dimensions = 1.43mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 3.78 grams Total Gemstone Weight = 0.37ct Total Metal Weight = 3.71 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
