Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.58mm width (at base) x 1.00mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with three white gold six claw settings, spanning across the top of the band, each housing one round brilliant cut diamond, graduating in size, largest to the centre, and claw set. The settings are supported with a decorative pierced gallery, and are secured between the tapering shoulders, of the plain and polished yellow gold band. Each of the shoulders are embellished with white gold shoulder plates, engraved and millegrain detail.



Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.04mm(L) x 3.00mm(W) x 1.99mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "J".

Dimensions (average) = 2.84mm(Dia) x 1.73mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 2.72 grams Total Gemstone Weight = 0.28ct Total Metal Weight = 2.66 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
