

## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand finished, raised 18ct yellow gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, with open back, setting underneath.

Feature; "solitaire dress style" design. Comprising a raised rub-over setting to top, rhodium plated to highlight, contains one round brilliant cut diamond, run-over set. The extended shoulders, taper up wide with a ripple feature to both sides.



Finger size = R.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si2", colour is "H", medium cut quality.

Dimensions = 4.72mm (average diameter) x 2.97mm (D-estimated)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 3.69 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.61 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
