Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.73mm width (at base) x 1.20mm depth, with a hollow top and shoulders, and a cut out curved underrail.

Feature cushion shaped top plate, housing nine round brilliant cut diamonds, varying in size, to the centre, claw set. The double surround and the tapering shoulders house a total of eighty-four round brilliant cut diamonds, also varying in size, and claw set. The top plate is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band.



Polished finish. Stamped '9K 1.00CT' - acid tested as 9 carat gold. Ring size: N.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.98mm(Dia) x 1.21mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.11mm(Dia) x 1.29mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Eighty Eight claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.84ct (estimated - see NOTE below)

Total Item Weight = 5.63gm Total Gemstone Weight = 1.00ct Total Metal Weight = 5.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
