One diamond is invisible set in the centre and is surrounded by rhodium plate four shared claw set and rhodium plate four claw set diamonds to form a stepped halo design. Channel set princess cut diamonds are displayed upon each upraised and square centre shoulder with rhodium plate claw set round brilliant cut diamonds in rows above and below. Exact replacement may be difficult.
