Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.84mm width (at base) x 0.80mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring. Five decorative shared claw settings, each housing one old cut diamond, spanning across the top of the band. The diamonds graduate in size, largest to the centre, and claw set. The settings are secured to the underrail and in between the shoulders of the plain and polished band. The shoulders are embellished with engraved detail.

Polished finish.

Stamped '904(engraved) illegible stamp' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains:

Five claw set old cut diamond, clarity is "P1 & P2 & P3" (mixed), colour is "I to J" (mixed).
Dimensions = 2.68mm(L) x 2.64mm(W) x 1.7mm(D-estimated) (smallest)
Dimensions = 3.09mm(L) x 3.06mm(W) x 1.95mm(D-estimated) (largest)
Total Weight = 0.52ct (estimated - see NOTE below)

Total Item Weight = 2.98 grams
Total Gemstone Weight = 0.52ct
Total Metal Weight = 2.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
