Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 2.01mm in width (at base) x 1.06mm depth, with a curved and split underrail, and open back settings.

Feature central four claw setting, housing one oval cut and faceted synthetic sapphire, claw set. Surrounded by sixteen single cut diamonds, illusion set. All secured between the tri-split shoulders of the yellow gold plain and polished band, with the central wire extended.

Polished finish - stamped '375 CR JP88' - acid tested as 9 carat gold. Finger size is .

The ring contains:

One claw set mixed cut oval shape synthetic sapphire, colour 'dark blue'.

Dimensions = 9.98mm(L) x 7.99mm(W) x 4.87mm(D-estimated)

Total Weight = 3.43ct (estimated - see NOTE below)

Sixteen illusion set single cut diamonds, clarity 'Vs & Si' (mixed), colour 'brown tint'.

Dimensions = 0.94mm (ave. diameter)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 3.13 grams - Total Gemstone Weight = 3.50ct - Total Metal Weight = 2.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
