Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.99mm width (at base) x 1.00mm depth, with open back settings, and a curved underrail.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. Surrounding is one row of eighteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, graduating in size, and channel set. Rhodium plating to the central setting area.

Polished finish.

Stamped '585 JP88' - acid tested as 14 carat gold.

Ring size: N.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Si2", colour is "I".

Dimensions = 3.94mm(L) x 3.92mm(W) x 2.39mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Twenty Eight claw and channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 3.04 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
