### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 10ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.82mm x 1.09mm depth, with open back settings.

Feature one row of seven round brilliant cut diamonds, spanning across the top of the band, slightly graduating in size, largest the centre, and end set. The settings are secured between the shoulders of the plain and polished band.

Polished finish,

Stamped '10K MHJ 0.26' - acid tested as approximately 10 carat gold.

The ring contains:

Seven end set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.93mm(Dia) x 1.18mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.24mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 2.42 grams

Total Gemstone Weight = 0.26ct

Total Metal Weight = 2.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
