### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 2.43mm width (at base) x 1.10mm depth, with curved underrail.

Feature; "solitaired style" design. Comprising, a raised white gold four claw setting to top, houses one round early brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band tapers up to the top, from both sides.

Polished finish, stamped "18ct, Pall" - acid tested as 18 carat gold.

Finger size = T.

The ring contains:

- One claw set early brilliant cut diamond, clarity is "P2", colour is "M" (light brown tint), medium cut quality.
- Dimensions = 4.57mm (average diameter) x 3.25mm (D-estimated) x 3%(Girdle Thickness)
- Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 3.79 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.71 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
