Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, ring, of hand assembled construction.

Plain, narrow, flat, tapered band of 3.48mm width (at base) x 0.96mm depth, with a curved underrail.

Feature central white gold illusion setting, within a four claw setting, housing one round early brilliant cut diamond, illusion set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band. The shoulders are supported with 'scroll' detail, and embellished with one single cut diamond, star set.

Polished finish.

Stamped '18CT PALL' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

- One illusion set early brilliant cut diamond, clarity is "P1", colour is "G".
Dimensions = 4.21mm(Dia) x 2.4mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.26ct (estimated - see NOTE below)
- Two star set single cut diamonds, clarity is "Si", colour is "H to I" (mixed).
Dimensions (average) = 1.69mm (diameter)
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 5.94 grams Total Gemstone Weight = 0.30ct Total Metal Weight = 5.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
