## Valuation for Traditional Retail Insurance Replacement

## Item 1

One 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.98mm width (at base) x 1.01mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature central square top plate within a four claw setting, housing four Princess cut diamonds, invisibly set. The setting is secured to the underrail, and in between the extended and pointed shoulders. Each of the shoulders, houses five round brilliant cut diamonds, graduating in size, and channel set. The shoulders lengthen out from the plain and polished band.



Polished finish.

Stamped '375 illegible stamp' - acid tested as 9 carat gold.

Ring size: L.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "J to K" (mixed).

Dimensions = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to K" (mixed).

Dimensions = 1.12mm(Dia) x 0.68mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 1.95 grams Total Gemstone Weight = 0.32ct Total Metal Weight = 1.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
