## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand finished, 18ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, narrow, tapered band of 1.85mm in width (at base) x 1.40mm depth, with open back (drilled) settings.

Feature single row spanning across the top of the plain and polished band, housing fifteen round brilliant cut diamonds, slightly tapering in size, claw set. Rhodium plating inside the setting area.

Polished finish.

Stamped '750' - acid tested as 18 carat gold. Marker's mark of 'Glenn Curtis' of 'Curtis Australia' being a member of the Gold and Silversmiths Guild of Australia.

Finger size is M.

The ring contains:

Fifteen claw set round brilliant cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'I to K' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.88 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 2.83 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
