Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of hand-finished construction.

Plain, narrow, low half round, tapered band of 2.29mm width (at base) x 1.02mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The top plate is secured between the extended and tapered shoulders of the plain and polished band.



Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "J".

Dimensions = 4.49mm(Dia) x 2.74mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.34ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to K" (mixed).

Dimensions (average) = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct estimated (estimated - see NOTE below)

Total Item Weight = 2.62 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.52 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
