Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.98mm width (at base) x 1.21mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature central round top plate, housing seven round brilliant cut diamonds, claw set. A floating surround, houses one row of twenty round brilliant cut diamonds, claw set. The top plate is secured between the extended and square shoulders. Each of the shoulders houses one row of seven round brilliant cut diamonds, bead set.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Forty One claw set and bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.53 grams

Total Gemstone Weight = 0.30ct

Total Metal Weight = 2.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
