## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 8.07mm at top to 2.63mm in width (at base) x 1.19mm depth, with a pierced and curved, decorative underrail.

Feature white gold 'shared cluster' style, three row design, housing a total of thirty-one round brilliant cut diamonds, tapering in size, illusion set. All secured between the shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Thirty One illusion set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to I' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.03mm(Dia) x 1.24mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.19 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 4.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
