Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, 'solitaire' design, diamond set ring,

Plain, narrow, tapered band of 2.78mm in width (at base) x 0.91mm depth, with a curved underrail.

Feature 'solitaire' style ring design, consisting of a six claw setting, housing one round brilliant cut diamond, claw set. Secured between the extended shoulders of the plain and polished band.

Polished finish.

Stamped '375 P' - acid tested as 9 carat gold.

Finger size is P.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'J'.

Dimensions = 3.92mm(Dia) x 2.39mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 2.42 grams

Total Gemstone Weight = 0.23ct

Total Metal Weight = 2.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
