Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 9.48mm at top to 2.84mm in width (at base) x 0.98mm depth, with hollow top and shoulders, and open back settings.

Feature multi-row ring design, consisting of a central double row, channel set with fifty-two baguette cut and tapered baguette cut (mixed) diamonds, tapering in size. Each outer row having fifteen single cut diamonds, bead set.



Polished finish - stamped '375' (faint) - acid tested as 9 carat gold. Finger size is P.

The ring contains:

Fifty Two channel set baguette cut & tapered baguette cut (mixed) diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).

Dimensions = 1.36mm(L) x 0.96mm(W) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(L) x 1.05mm(W) x 0.60mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Thirty bead set single cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'H to J' (mixed).

Dimensions = 1.15mm (ave diameter)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.68 grams - Total Gemstone Weight = 0.70ct - Total Metal Weight = 3.54 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
