Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring. Plain, narrow, tapered band of 2.70mm in width (at base) x 1.41mm depth, with a curved and pierced 'plaited' underrail.

Feature central 'cluster' housing nine round brilliant cut diamonds, four largest, tapering in size to one sunken set to the centre, and alternating with four smallest, claw set. Surrounded by twenty-four round brilliant cut diamonds, with three 'leaf' settings under each setting side, bead set with three round brilliant cut diamonds. Secured between the split shoulders of the plain and polished band. Each shoulder having six round brilliant cut diamonds, tapering in size.



Polished finish - stamped '375 JP02' W008' - acid tested as 9 carat gold. Finger size is O.

The ring contains:

Four claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H to J' (mixed).

Dimensions (average) = 3.40mm(Dia) x 2.07mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Fifty Nine sunken set, claw set & bead set (mixed) round brilliant cut diamonds, clarity 'P1 to P3' (mixed), colour 'G to I' (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.99 grams - Total Gemstone Weight = 1.60ct - Total Metal Weight = 5.67 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
