Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.79mm in width (at base) x 1.14mm depth, with a split and curved underrail, and hollow open back settings.

Feature yellow gold multi-claw setting, consisting of multi-level white gold claws, with illusion plates, housing one round brilliant cut diamond, largest to the centre, tapering in size, illusion set. Secured between the extended and plaited shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Nineteen illusion set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'light brown tint'.

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.65 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
