Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, multistone pendant, of hand-assembled construction.

Feature 'heart' shaped pendant, with four rows housing a total of twenty-two single cut diamonds, to one side of the heart, graduating in size, channel set. On the other side, are two rows of tapered baguette cut and baguette cut diamonds, also graduating in size, and channel set. Rhodium plating to the diamond setting areas.

Pendant dimensions = 28.00mm (ave. length) x 20.00mm (ave. width) x 5.00mm (ave. depth).

Polished finish. Stamped '375(faint)' - acid tested as 9 carat gold.

The pendant contains:

Thirty Six channel set tapered baguette cut and baguette cut diamonds, clarity is "Si & P1 & P2", colour is "H to light tinted brown".

Dimensions = 1.32mm(L) x 0.84mm(W) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.66mm(L) x 1.18mm(W) x 0.86mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Twenty Two channel set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 1.09mm (diameter) (smallest)

Dimensions = 1.41mm (diameter) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.66 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.57 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
